Name and Vitae

Marlene Bayless, an administrator with the Portland Public Schools, is a specialist in intergovernmental relations. She has served on the executive boards of the World Affairs Council and the YMCA. Has experience with Model Cities, the Urban League, the Human Relations Commission and was a member of the Tri-County Local Government Commission, the group that initiated the formation of METRO.

George Beard, Acting head of Planning and Acquisition Section, Division of Information Services Bonneville Power Administration. Mr. Beard is a graduate of the Graduate Public Administration Program at PSU and was a Presidential Management Intern with the U.S. Justice Dept. and BPA.

Philip R. Bogue, Assistant to the President of PSU for University Relations, is a CPA and was long-term managing partner of Arthur Andersen & Co. until his retirement in 1982; is a past member of the Tri-County Local Government Commission, a former president of the Oregon Symphony Association and has served the United Way, the Boy Scouts, Pioneer Square, the Burnside Consortium, the World Affairs Council, and as 1976 president of the Chamber of Commerce as part of his heavy civic schedule.

Keith Burns, an attorney, is a former legislator in both houses and served as Executive Assistant to the Governor. During his legislative tour he was instrumental in passage of C.R.A.G. bills and MSD enabling bills; he was active in election campaigns for METRO and its ballot measures.

Dr. Ronald C. Cease, current president of the Metropolitan Citizens League, is a director of the masters program at Portland State University, chaired the Tri-County Local Government Commission, and was also the first chairman of the Portland Metropolitan Area Boundary Commission. He has served as a dean and political science professor at PSU.

Lynn Dingler, Northwest regional energy director for Area 15 Homebuilders. Member of the City Club, Metro Crisis Intervention Service member, past president of Sellwood-Moreland Improvement League, immediate past chair of Multnomah County Democratic Party.

Jeanette Egger, Executive Secretary, is a self-employed research consultant. Her long record of civic involvement includes the boards of the Oregon Environmental Council, Citizens for Better Transit and AAUW. She also served as citizen chair of transportation and street standards for Lake Oswego Comprehensive Plan.

Muriel Goldman is a trustee of the Morrison Center, Waverly Children's Home, and Mental Health Services, West; member of the St. Vincent De Paul Child Development Scholarship Committee; serves on the United Way Program and Allocation Committee, and the Oregon Juvenile Services Commission.

Rusty Goldy, Executive Director of the World Affairs Council of Oregon, did much to orchestrate the operation of the Metropolitan Citizens League by performing most of the original staff work as a volunteer. She has run political campaigns, lobbied for Medicare, served Planned Parenthood (Speakers Bureau), taught in the public school system, and has served on the board of the Oregon High Desert Museum.

Carl Halvorson, president of the prominent contracting firm that bears his name, was vice-chairman of the Tri-County Local Government Commission. A former president of the Portland Chamber of Commerce, he has also chaired the Board of Trustees of Emanuel Hospital; been on the board of directors of Lewis and Clark College and Blue Cross. Within the past two years, he acted as chair of the United Way campaign; and recently assumed the post of president of the executive committee of the Washington Public Power Supply System (WPPSS).

Charles Kemper, program manager of R.A.Wright Engineering Co., was director of the original Metropolitan Service District from 1972 to 1979. He is an engineer and has served on various DEQ committees.

Edward H. (Ned) Look, Executive Director of the Oregon Community Foundation and former vice president of the First National Bank, has chaired the Auditorium Renovation and City-County Civic Center Committees. He was a prominent member of the Portland Development Commission and has been active in city-county consolidation efforts, and the Local Government Committee of the Portland Chamber of Commerce.

(*) Footnote: Due to conflicting commitments, Mr. Look recently resigned from the board of the Metropolitan Citizens League. His replacement has not yet been chosen.

William Moshofsky, an attorney, was vice-chairman for Governmental Affairs for Georgia-Pacific Corporation; was the 1982 Republican candidate from Oregon's 1st Congressional District. His many civic activities include the Oregon Council on Crime and Delinquency, the Portland Chamber of Commerce, the National Forest Products and National Chamber.

Burke Raymond, vice-president of the Metropolitan Citizens League. Active in the city manager movement. Has served as city manager for cities of Beaverton and Gresham, Currently serving as coordinator of sewer development for Multnomah County.

A. McKay Rich, presently assistant director of the Washington Park Zoo, has a long record in regional governmental activities. He headed the staffs of both the Tri-County Local Government Commission and the Portland Metropolitan Study Commission, was the assistant director of C.R.A.G., and assistant to the executive officer of Multnomah County. His background also includes elected legislative and city council experience.

Kenneth Martin, Executive Officer of the Portland Metropolitan Boundary Boundary Commission. Serviced the Finance and Land Use committees of the Tri-County Local Government Commission, and directed the activities of staff interns acting for the Commission. Actively involved in televising of League's regional government education program.

Eugene Peterson, long-term employee of Bureau of Land Management, and civic activist in neighborhood associations and affairs; one of the group of councilors elected to the original METRO council in 1979.

Robert G. Simpson, an attorney, was the first president of the Metropolitan Citizens League, and the principal instigator in forming the organization. He was also a member of the Tri-County Local Government Commission and chaired the Portland Metropolitan Study Commission throughout most of its existence, from 1963 to 1971.

Robert E. Stacey is a staff attorney and land use advocate for 1000 Friends of Oregon. A member of the State Bar's Continuing Legal Education in local government, he has published planning case studies and is a contributing editor to the Oregon Real Estate and Land Use Digest. He also served the 1980 Legislative Interim Committee on Zoning.

Jerry Tippens was senior associate editor of the Oregon Journal until its merger with the Oregonian where he is now associate editor. He was the second person to chair the Portland Metropolitan Boundary Commission, and has been involved in legislative reform and state government reorganization.

Bob Weil is a management consultant specializing in retailing, and is currently serving as treasurer of the Yale Alumni Association of Oregon and as treasurer of the Morrison Center for Family and Youth Services; member of the Portland Metropolitan Boundary Commission and the OMSI Advisory Council and the City Club.

Beth Blunt, Executive Director of the Metropolitan Citizens League. Public affairs specialist. Involved in Oregon Ass'n for Adults and Children with Learning Disabilities. President of Regional League of the League of Women Voters. Member of the City Club.
