Dear Friends,

The problems facing our region have required regional solutions, and we have, through the perseverance and efforts of many of us, seen the emergence of the Metropolitan Service District as a viable governmental entity for addressing these issues. However, beyond Metro there is a need for a Metropolitan Citizen Group dedicated to the issues and concerns involving the total region as well as to the monitoring of the activities of Metro.

In 1977 after HB 2070 became law and prior to the completion of the work of the Tri-County Local Government Commission, some of us who were members of the Commission took steps to begin the formation of a Metropolitan Citizens League. Articles of incorporation were drafted and then our efforts took the direction of helping in the campaign to pass the measure, then to monitor the transition from the old MSD to the new integrated MSD.

Others who have complicated governmental structures in their regions have seen the need for a citizen involvement mechanism. The Citizen League in the Minneapolis, Minnesota, region has been most effective in steering the region through these difficulties to innovative regional solutions.

Here in the Portland area historical, traditional boundaries have created difficulties in finding solutions for issues such as Johnson Creek. The population to be served by government straddles boundaries. We have now a governmental agency that can approach

this issue, and we need an active Citizens League to monitor that agency and to address regional issues.
