Council President Peterson introduced Metro staff Ted Leybold, Transportation Policy and Program Director, and Grace Cho, Principal Transportation Planner, to present on the topic of the 2028-2030 Regional Flexible Fund New Project Bond Development Process, Updates, and Input.

Staff pulled up the "2028-30 Regional Flexible Funds Allocation (RFFA) Step 1A.1" slides to present to Council.

Staff Presentation

Presenters explained how the Regional Flexible Funds are allocated to each Metropolitan Planning Organization (MPO) by the federal government and highlighted the estimated

amount of funds for 2028-2030. Presenters reviewed the findings from the initial bond scenario assessment and shared the timeline for the bond proposal.

#### **Council Discussion**

Councilor Rosenthal asked for clarification on the dollar amounts for the funds.

Councilor Gonzalez emphasized Metro's role in fulfilling the fiduciary responsibility while delivering meaningful projects. Councilor Gonzalez listed 82nd Avenue, TV Highway, and Sunrise Corridor as funding priorities for the three counties.

Councilor Lewis expressed appreciation for the insight into the funding framework for accomplishing important project goals and inquired if contemplating the bond on top of the current bond would reduce spending power in step 2.

Presenters clarified the time frame for the bond cycle and payment schedule.

Councilor Lewis advised being open to early signals from new administrative officials on whether existing programs will remain priorities.

Presenters responded that monitoring the federal situation would be key to establishing the bond approach.

Councilor Hwang asked whether there was an application of racial equity in identifying the themes.

Presenters explained that there were three technical evaluations, and the Regional Transportation Plan (RTP) objectives analysis had more specific measures and criteria for looking at racial equity.

Councilor Hwang requested a clearer articulation of racial equity practices in future discussions, and asked if bonding success is based on agency rating or interest rates and timing.

Presenters responded that the initial analysis is based on cost estimate of all of those factors, including timing.

Councilor Lewis asked if the staff had created a hybrid scenario with both Metro and TriMet administering the bonds.

Presenters stated that the hybrid scenario was based around reliance on federal bonding programs and would result in higher costs and less revenue.

Council President Peterson advised making efforts to move forward with preparations rather than overthinking the scenarios.

Seeing no further discussion, Council President Peterson thanked the presenters and moved on to the next agenda item.
