

This letter has been written because I have grown increasingly concerned about the inaccurate information that your Campaign Committee has been circulating with regard to the possible selection of Jeep Trail as a sanitary landfill.

Contrary to your Campaign material, Metro and DEQ have not selected the Jeep Trail location for a sanitary landfill. Furthermore, neither Metro nor DEQ can have authority to site a landfill without the prior consideration of the Multnomah County Board of Commissioners "elected officials or without a declaration by DEQ of an emergency" pursuant the provisions of Senate Bill 925.

In the interest of accuracy and fairness to the voters in Northwest Portland, I would like to review some of the history involving Metro, DEQ and Senate Bill 925 in the context of the ongoing discussions with regard to Jeep Trail:

1) As you know, the people of the Tri-County Region voted to create Metro in May 1978.

2) The voters again gave directly elected metropolitan government a vote of confidence by electing 12 District Councilors and an Executive Officer in November 1978.

3) Pursuant to the authority given to Metro

by the people in this Region, the Metro Council began to evaluate the most desirable methods for solving a serious

public health and environmental problem - namely, the disposal of solid waste.

In order to begin implementing a comprehensive solid waste management program, the Metro Council and Metro's Executive Officer drafted a number of proposals for consideration by the Oregon Legislature during the 1979 session.

One of the pieces of legislation that Metro sought came to be known as Senate Bill 925. This Bill, which was supported by Republicans and Democrats and signed into law by Governor Atiyeh is designed to help advert an emergency solid waste crisis in Oregon. Senate Bill 925 reaffirms local government control by requiring elected city and/or county approval for conditional land use permits i.e., landfills.

DEQ can act only if local officials fail to issue a conditional use permit providing a landfill and only if a "state of emergency" is declared.

Therefore, your campaign literature is incorrect and misleading when you declare that Metro and DEQ is about to site a landfill without an opportunity by the people in the affected neighborhoods to have their views considered by elected officials.

Mardi, I trust that you will take whatever action is necessary to correct the inaccurate information that is being disbursed by your campaign organization.

You may be assured that Multnomah County Commissioners, Metro Councilors and DEQ officials will continue to conduct rigorous engineering, environmental and economic studies in order to determine the feasibility and advisability of selecting Jeep Trail as a landfill site. I hope that we can count on you to make sure that government officials and candidates for public office conduct themselves in a fair and responsible manner concerning an issue of vital importance to the people of this metropolitan region.

WHEREAS, The Council directed that a Management Review Committee be established to review Portland Recycling Team's management structure and function; and

WHEREAS, The Council believes that the Portland Recycling Team should be required to develop an acceptable business plan as a condition of the contract with Metro to partially fund the warehouse, drop centers and monthly projects; now, therefore,

BE IT RESOLVED,

b. Projected operating expenses.

Estimated operating expenses, by month, shall be separately stated for personnel, trucking, and general and administrative expenses.

c. Net Monthly Profit or Loss.

Revenues and expenses projected under paragraphs (a) and (b) shall be correlated and a projection of profit or loss, by month, for the term of the contract shall be stated.

3. The business plan and its updates will serve as a point of review for the Management Review Committee established under the terms of the PRT/Metro contract.

4. That the contract authorized by paragraph 3 of Resolution No. 81-212 shall contain a condition that no funds shall be paid to Portland Recycling Team by Metro under the contract until the business plan is submitted to, and approved by, the Metro Executive Officer.

Dear Rolf:

I appreciate your letter of July 2 regarding the idea of providing advance ticket sales to the Jazz Concerts.

I have discussed the matter with our Executive Officer Rick Gustafson and the Zoo staff. They have taken steps to solve the immediate problem and will seriously consider the question of advance ticket sales.

The information that you received from Meier & Frank was somewhat misleading. As a policy matter Metro has taken no stand on "advance ticket sales" so long as they are in conformance with our existing ordinances on fees, etc.

As you can imagine, the Zoo staff has been somewhat overwhelmed with the success of the concerts and the high attendance has created several difficult problems. First, the parking has developed into a tremendous inconvenience not only for the Western Forestry Center and OMSI who occasionally have Wednesday night events, but also for the Highland Neighborhood which is having increased intrusion into their streets and in front of their driveways, along with associated behavioral problems. Our endeavors to establish the shuttle bus service from Sylvan is an attempt to cope with this.

A related problem is the capacity inside the Zoo. We are already at a point where there is insufficient room to adequately and safely handle the crowds we are now experiencing.

Another factor is that on these nights the Zoo is open to people who simply want to visit the Zoo. We can't, without a very well-thought-out plan, close it off to them for that is the reason for having the Zoo -- not to provide a concert site. Mr. Rolf D. Glerum July 13, 1981 - page 2

There may be a way to use your advance tickets sales idea that would help with these problems and I can assure you that Warren and his staff will investigate it thoroughly. Obviously there are accounting, gate availability, crowd control, capacity and other problems to be considered. I can't promise you an immediate answer, but we will work on it and appreciate the thought and time that you gave it.

If you attended last Wednesday night's concert (July 8), things worked considerably better. The shuttle worked very well with 700 round trip riders as opposed to 70 the week before. Unfortunately, the main lot was closed off too soon and we needed more shuttle buses; next week we will improve coordination and there will be fives buses instead of three. It is my understanding that the lines were greatly speeded up, and I am certain that this will also be improved.

Please let us know any additional thoughts that you have on this. And I thank you for writing and wanting to help us.

Edmond Burke, a British intellectual, once said,..."all that is needed for evil to triumph is that good men do nothing."

My colleagues, Councilors Banzer, Kafoury, Burton, and I believe that the time has come for us to speak out against a pattern of deception along with some muddle headed thinking that is being used to provoke descension, fear and division among the people of this metropolitan region.

We strongly object to, and 'will actively oppose, the tactics and statements of a small, self-appointed group of nay sayers who call themselves "Enough is Enough."

While we defend every Oregonian's right to speak out as free citizens, we cannot remain silent when some deliberately misrepresent, or to put it more bluntly, lie, to the people about Metro's procedures and policies.

Furthermore, we believe that it is our responsibility to expose their misrepresentations and the havoc that will result if this would-be band of mischiefmakers have their way.

Every citizen who is asked to circulate or to sign an abolish Metro petition should be aware that the leader of Enough is Enough, Mr. Don McIntire, misrepresented Metro's housing goals when he said that they contain "sexual preference" language. That is a false statement, and he knows it. In the interest of decency and honesty we demand that he publicly acknowledge his misstatement and apologize for it.

Every citizen who is asked to circulate or to sign a petition abolishing Metro should think carefully about turning over two of Metro's responsibilities, management of the Zoo and garbage disposal, to non-elected state bureaucracies. We ask Mr. McIntire and those who follow him how county and local governments will be enhanced and protected by having non-elected bureaucrats in the Oregon Department of Fish and Wildlife and the Department of Enviromental Quality manage the Zoo and disposal of our garbage.

My colleagues and I do not know one responsible city or county official in the metropolitan region who wants the State of Oregon or their own governmental jurisdiction to assume the responsibility for managing the Zoo and/or Solid Waste disposal.

During a period of diminishing resources, elected officials and citizens of good will are working to improve the delivery of needed services and to enhance regional facilities like the Zoo. The thousands of people who visit the Zoo see the improvements made possible by the people of the region working through their directly elected government, Metro. Likewise, informed and responsible people throughout the region are increasingly impressed by the progress that Metro, in cooperation with local government officials, is making in Solid Waste Management. As Metro Councilors, we are pleased to work with those citizens who seek to build a more liveable metropolitan area with governmental institutions that are responsive to meeting the people's needs. We believe that the people want to build and improve our region's resources rather than destroy them. And, we believe that the people of this region want to keep their right to directly elect those who make decisions affecting them.

Therefore, we are confident that the people will reject the siren song of Mr. McIntire and his supporters who would seek to divide us with scare tactics, misrepresentations and ill-advised solutions. We trust that other citizens and public officials will also speak out in the interest of providing the people with accurate information concerning Metro's role in our region.

Together, we are confident that we can overcome the unethical tactics of those who would destroy what the people in this region have built.

Resignation Statement by Craig Berkman Metro Councilor

December 8, 1982

1978 was the year the voters of the Tri-County created an elected Metropolitan Service District. As one of the initially elected MSD councilors, I shared the optimism and expectation that this first directly elected, multi-purpose regional government would succeed in helping to improve the delivery and management of local government services.

My objectives were to improve the funding base and operation of the Zoo and to conceive and hopefully begin to implement a comprehensive and practical solid waste management and disposal system. My primary focus on these two areas of Metro's responsibilities was based on the conviction that Metro had to earn the support and trust of its new constituency by discharging its initial responsibilities well.

During the past four years of my service on the Council, many of my personal objectives have been realized. In the solid waste area, my initiatives on the Council resulted in new State legislation providing for emergency land fill siting by DEQ, exempting Metro from the Sherman Anti-Trust Act with reference to Metro's ability to control the flow of waste in the region and a specific proposal for an energy recovery facility for the region. My support for an expanded and quality Zoo was exhibited by the role I assumed in raising money for the Zoo serial levy as the initiator of the Oregon Symphony Pops concern on behalf of the Zoo. Through the years I have worked closely with Warren Iliff and his staff in order to enhance the quality and diverse programs that the Zoo now offers our community.

In addition to these areas of activity, I also sought to improve Metro's internal financial reporting and accounting system. As Chairman of Metro's Audit Committee, I believe that significant progress has been made to overcome the problems reported last year.

In recent months, my professional and business responsibilities have increased significantly. Of necessity these business activities require extensive travel, which coupled with an increasing Metro meetings schedule, have resulted in my inability to devote the time necessary to be an effective councilor. Because my business responsibilities and travel will continue for an extended period, I have decided to resign from the Metro Council. The effective date of my resignation will be January 11, 1983 in order to give newly elected Metro Councilor the opportunity to select my replacement

I want to thank my Council colleagues, Executive Director and Officer Rick Gustafson and the Metro staff, for their cooperation and friendship through the years that we worked together. Most of all I wish to thank the people of West Portland, and East Washington County for the confidence they

SUBJECT: Council Presiding Officer Selection Process

Since Metro's creation in 1978, the Council has for the most part selected the presiding officer in a rather informal and invisible manner. The formal electoral process, i.e., the formal Council vote, has in the past given the public very little, if any, insight as to the reasons why the Council has selected the presiding officer.

Upon reflection, I believe that this process can be improved by providing the opportunity for public, on-the-record information during the formal Council deliberation at the beginning of each calendar year.

Therefore, I propose that each candidate for presiding officer be given the opportunity to publicly explain the reasons for their candidacy and their suggestions for how the Metro Council should conduct its business during 1983. In addition, I believe that each Councilor, who chooses to do so, be given the opportunity to express his or her reasons for supporting the candidate of their choice.

An open, on-the-record discussion would help the public and those who cover our activities understand the priorities and commitments of those who seek to lead the Council.

I trust that a majority of my Council colleagues will support this suggestion by adopting this procedural change for 1983.

STATEMENT BY RICK GUSTAFSON

REGARDING THE RESIGNATION OF CRAIG BERKMAN

Craig Berkman has served four years as the first Councilor from District 3. He has done an excellent job serving the Council, the policies and interests of this organization. He departs with a fine record of contribution in solid waste, Zoo and our financial matters. Unfortunately, Craig is experiencing time constraints in being able to properly maintain his responsibilities as Metro Councilor and attend to business and family as well. It is with regret that I see Craig leave because he brought a very important business perspective to the Metro Council and he will be missed.

I would like to take this opportunity to highlight some of his more significant accomplishments:

- 1. Chairman of the Audit Committee. Craig chaired the Audit Committee during this last year in a period where Metro's financial matters were under close public scrutiny. He chaired that Committee in a responsible fashion, assisted us greatly by exhibiting patience and diligence in reviewing our financial matters and providing excellent advice. Certainly Craig's background in business and finance served Metro well in carrying out that responsibility.
- 2. Energy Recovery Facility. Craig recognized early that the energy recovery project was an important element in solving the solid waste problem. Craig took on the assignment of Council representative on that issue. He attended hours and hours of meetings through the proposal process, the interviews, the selection of Wheelabrator-Frye Inc., insurance development, tax credit development, Again, Craig's business experience was extremely etc. valuable in providing advice in the negotiations and approaches to handling the issue of solid waste. He was a leader in recommending improvement of staffing and management in Metro's Solid Waste Department, recognizing the significant investments being made in our solid waste program.
- 3. Emergency Siting. Early in his term of office, Craig initiated the Emergency Siting legislation that will allow the State of Oregon to declare an emergency and site a landfill over the objections of a local jurisdiction. Craig understood the difficulties we would face siting a regional landfill. While supportive I did not think the legislation would pass, but proceeded to carry out the policy of the Council, led by Craig, and sought passage of SB 925. It passed and a great deal of our success rested on Craig's diligence and determination to address a significant public issue.

4. Zoo. Few people realize the key role Craig played in fund-raising for the Zoo. Again, he chose a role where he could be most helpful--fund-raising. Through his business contacts and hard work, he was successful in raising money for the Zoo serial levy campaign effort. His skills were also valuable during the Metro tax base campaign. His assistance was not only helpful but a meaningful contribution as a member of the Council.

The kind of business background Craig provided is important on the Metro Council. It is unfortunate that the time demands are such that he is unable to continue to serve. His experience and knowledge, both professionally and as a member of the Metro Council, are invaluable.

MSD councilor to resign post

Craig Berkman, the Metropolitan Service District councilor who has missed the most council meetings this year, announced Wednesday he will resign his post Jan. 11.

"You can't be effective if you're not there," Berkman said, adding that family and business obligations caused him to miss 14 of 22 council meetings so far this year.

All other members of the council have missed six or fewer meetings, according to attendance records kept by the district.

Berkman was elected to serve on the regional government council in 1978 and was re-elected to a four-year term in 1980

In a statement released Wednesday, Berkman claimed credit for improvements at the Washington Park Zoo and for 1979 legislation authorizing the state Environmental Quality Commission to site a garbage landfill over local opposition.

He also said he was instrumental, because of his connections with officers of Wheelabrator-Frye Inc., in keeping alive negotiations for construction of a garbage-burning plant in Oregon City.

In his resignation statement, Berkman said officials of the service district

must continue battling to restore public confidence in the agency which was lost earlier this year after reports of financial irregularities and accounting mistakes.

"There are a lot of things they have to do to establish and regain credibility," he said.

In addition, he suggested state legislation to allow members of the council to remove the district's executive officer for "malfeasance or misfeasance."


Under current law, the executive officer shares authority for running the district with the council. Berkman suggested that the council should be able to remove the executive officer on a vote of nine of its 12 members.

'The council should be like a board of directors. It should set policy and hold the executive officer responsible for carrying out that policy," he said.

"That's an interesting proposal," Executive Officer Rick Gustafson said later Wednesday, adding that he knew of no similar procedure in the functions of local government agencies.

Gustafson praised Berkman's service on the council and said he "tended to support administration proposals" while continuing to be an independent council member.

Cindy Banzer, presiding officer of the council, said she accepted Berk-

man's resignation "with deep regret." She said the resignation illustrates Berkman's "commitment to his community and his concern for good public policy development and implementa-

During his four years on the council, Berkman was a strong supporter of the district's proposal to build a garbageburning plant in Oregon City. Plans for the plant were abandoned after voters in Clackamas County approved a number of ballot measures in the Nov. 2 election intended to block construction.

Berkman acknowledged Wednesday that no such plant could be built without the approval of local officials, but he said a burner is needed for Portland.
