
Dear Mr. Bromley:

BETTY SCHEDEEN STATEMENT  
JOHNSON CREEK LID  
June 27, 1980

This is one of the most difficult votes we have had as a Council. I am disappointed that Metro has not had more support for cleanup of Johnson Creek. It is needed and the current offer of \$4.3 million from the Corps of Engineers is a bargain for the residents of the Basin.

For a year we worked with the Corps of Engineers, 4 cities and 2 counties in the Basin. We helped them find a process all could agree on. For the first time in 30 years, an answer had been agreed on. In addition we have a responsibility to the jurisdictions with whom we worked, and who loaned us the money to create the LID.

However, remonstrances from 6600 plus residents means there are many more who did not respond because they did not understand or did not meet the deadline.

In addition, 1629 or more did not receive their notices. With this in mind, I must vote "No."

Though Jane Rhodes, her Task Force and our staff have tried very hard and believed in the project, it appears that the process was not open enough or we did not educate enough.

We have been so anxious to solve this problem, we now have and left a lot of bruised residents all over the Basin who did not feel they were brought into the process.

I am further concerned there will be unending stumbling blocks presented by the residents such as the appeals process,



determination of cost benefits, remonstrances before each phase, lawsuits, any or all of which could lead to failure.

Metro has met its responsibility by putting together a solution. The decision is now the landowners. They say no loud and clear. We perhaps should have taken more time involving the people or possibly the LID process may not be practical in a region so large.

Below is the statement I made explaining my "No" vote on the Johnson Creek Local Improvement District (LID). There is no question in my mind that there is a need to solve the long-standing flooding and pollution problems of the Creek, but as stated, I did have questions about the process.

Now that the LID has been formed, I am committed to work with the community to help citizens understand the project and to involve them in the process. Certainly one result of this effort could be to find another funding source for the Phase II improvements.

I'd very much appreciate your thoughts on this project. Please call me if you have questions or words of advice.


