Honorable Council:

It has been brought to my attention that there is some concern about my prior public service experience which I failed to document in my application.

Accordingly, with this letter I would like to supplement my application and the interview process with a listing of some of my more significant involvement in public service as I can best recall.

1983

Washington County - Participating in review of Washington County Comprehensive Plan and Community Development Ordinances.

1982

Washington County - Member of Ad Hoc Ordinance Review Committee for Washington County Comprehensive Plan including community plan organization leadership, rural and urban interest groups and development interest. Initially the planning department organized two committees: Builders and Developers et at, and C.P.O's and Interested Citizens.

At the onset of this work program I recommended to both groups that we should insist on working together to insure good communications and understanding of the respective interests so that the areas of disagreement could be reduced to the minimum possible.

Beaverton - Contributed to campaign to prevent unworkable charter changes. Reviewed proposed subdivision ordinance changes (also same in 1980).

Metro - Commentator on regional surface water management plan through co-mittee member (Mike Robinson) active in regional transportation plan on individual basis.

Sunset Corridor Assn. - Charter affiliate member and member of transportation and land use sub-committees.

Received First National Good Neighbor Award" from the National Association of Counties "in recognition of outstanding community contributions in public and private cooperation".

This was for organization of the Cornell Road improvement from 185th to 158th, a major county arterial at no cost to the general public.

National - Participated in efforts with Les AuCoin to secure transfer funds for regional transportation projects which resulted in construction of 158th and 185th improvements just being completed.
