Voters re-elect three members of MSD

Portland area voters re-elected three members of the Metropolitan Service District Council while turning a fourth out of office in Tuesday's primary election.

Elected to new four-year terms were Thomas W. DeJardin who was unopposed; Jim Gardner, who defeated one opponent; and Tanya Collier, who overcame a spirited challenge in her bid for her first full four-year term.

Rejected by the voters was their fellow incumbent, Larry L. Cooper, 45, who came in third in a three-way race.

As a result, voters in Council District 10, which extends from Northeast Portland to the David Douglas School District, will have the only Metro Council run-off race in November, pitting Roger Buchanan, 56, a labor arbitrator and negotiator, against David Little, 27, a job service representative with the Oregon State Employment Division.

Based on final, unofficial returns lacking only absentee ballots that must be counted by Friday, Buchanan received 47.3 percent of the votes cast Tuesday, just short of the majority he needed to avoid a runoff. Candidates in two other districts — Lawrence Bauer and Richard Devlin — were more successful, receiving more than 50 percent of the votes cast in their respective races. They, along with Collier, DeJardin and Gardner, will not have to undergo another campaign in the fall and are assured of taking office next January.

Votes tallied in the six Metro Council races were:

• District 2 (Beaverton-Aloha) Lawrence Bauer, 43, planning consultant and former aide to the Beaverton mayor, elected, 5,279; G. Glen Comuntzis, 1,045; Lewis Scott, who had withdrawn from the race, but was still listed on the ballot, 3,373.

• District 3 (Southwest Portland-Washington County) Jim Gardner, 42, incumbent and a vocational rehabilitation specialist, 12,830; Tyler Marshall, 4,750.

• District 4 (Tigard-Lake Oswego) Richard Devlin, 35, Tualatin City Council member and juvenile detention worker, 7,844; Mac Crocker, 4,116.

• District 5 (Oregon City-Wilsonville) Thomas W. DeJardin, 48, incumbent and businessman-investor, 10,544.

• District 9 (Southeast Portland) Tanya Collier, 40, incumbent and

Thank you for meeting with us January 30th to discuss Metro's Natural Areas, Open Space and Corridors Planning Program. Our desire was to explore possible federal funding and share with you a more complete picture of the region's efforts:

- the planning process' broad-based support from and involvement of cities, special districts, counties, the private sector, parks advocates, and state and federal agencies;
- o the initiation and acquisition of color-infrared aerial photographs for the four county metropolitan area -- the first regional photographic update since 1980 and a superior planning tool to identify natural areas, open space and possible corridors; and
- the current analysis and inventory of the region's remaining natural areas -- rivers, streams, wetlands, riparian areas, uplands, meadows, forests, greenways that will enable the region to begin to identify potential sites for preservation, protection and acquisition.

As we discussed, the development of the Regional Plan for Natural Areas, Open Space and Corridors is on track for six phases, with Phase I completed in June 1989 and Phase II "Inventory Work, Site Visits and Mapping of Natural Areas" currently underway. During the next two years we clearly have within our grasp the capability of making this plan a reality. However, we are at a the point where our ability to stay on schedule is dependent on funding for the project.

We are committed to utilizing all funding sources at our disposal (local, regional, state and private). However, we anticipate these sources will be inadequate and that we are at risk of losing the critical momentum and regional consensus that this program has generated. In light of this conclusion we have directed agency staff to analyze all potential federal funding sources. At our January 30th meeting Community Development Block Grants (CDBG) and Urban Development Action Grants (UDAG) were mentioned as possible resources. Our

You have asked me to draft amendments to Resolution No. 91-1467 to make its tone more positive. I have reviewed the resolution and propose the following amendments:

EXHIBIT A

1. All councilors have a right to debate each matter brought before the Council. There shall be [no debate on any matter unless there is] a question before the Council <u>prior to debate on any matter</u>.

2. A Councilor speaking on a motion [must] <u>shall</u> confine his or her remarks to the matter under consideration by the Council. . .

3. A Councilor may speak [only] once for [not more than] <u>up to</u> five (5) minutes on each main motion and substantive amendment to a main motion before the Council. . . .

4. . . The closing comments shall be limited to [no more than] three minutes unless extended . . .

EXHIBIT B

4. . . The following items [shall not be referred to a committee by the Presiding Officer but] shall be considered and acted upon by the Council as a whole, rather than referred to a committee by the Presiding Officer:

Exhibit C, #5 (page 8): Any ordinance or resolution which remains in a standing committee over six (6) months from the date it was introduced shall be considered to be defeated and shall be filed with the Council Clerk and receive no further consideration. The <u>Presiding Officer</u>, or the Council by a majority vote of a quorum, [or the Presiding Officer] may remove any ordinance or resolution

Exhibit C, #6 (page 8, last sentence): The report shall state the committee[s] recommendation, . . .

Exhibit D, #1: Citizen Communications to the Council on Non-Agenda Items

Exhibit E, #1: Agenda items may be placed on the consent agenda if they conform to the following <u>criteria</u>: . . .

Finally, I have a question about minority report procedure. Item #4 in Exhibit A states, "The Councilor who moves and presents the committee or minority report on a matter before the Council is entitled to close the debate after other Councilors wishing to speak have spoken." In the case of a minority report, the procedure calls for the committee report to be presented, followed by the minority report, discussion of the minority report, and closing by the minority report's presenter. Is it your intent to prevent the committee report's presenter from having a final word - either before or after closing comments are given on the minority report?
