Please note the attached census information published in <u>The Oregonian</u>. I thought it would be of assistance with regard to the Metro Charter Commission work.

CENSUS 1990: WHAT THE FIGURES SHOW

Q. What is the fastest growing minority group in Oregon?

A. The population of people of Asian or Pacific Islander origin nearly doubled between 1980 and 1990. People of Hispanic origin make up the second group at more than 70 percent. The number of blacks grew by 25 percent.

Q. What is the fastest growing minority group in Portland?

A. Portland's Asian population more than doubled, growing by 118 percent in the last 10 years.

Q. What is the largest minority group in Oregon?

A. People of Hispanic origin comprise 4 percent of the state's population, up from 2.5 percent in 1980. Asians are next; they make up 2.4 percent of the population. Q. What is the largest minority group in Portland? A. Blacks make up 7.7 percent of the city's population. Asians account for 5.3 percent.

Q. Which of Oregon's 10 largest cities has the highest percentage white population? A. Lake Oswego with 96.2 percent. Springfield is second with 95.4 percent. (The overall percentage in Oregon is 92.8 percent.)

Q. Which of Oregon's 10 largest cities has the highest percentage of persons of Hispanic origin? A. Hillsboro with 11:2 percent. Salem is second with 6:1 percent.

Q. Which of Oregon's 10 largest cities has the highest percentage of Asians? A. Corvallis with 8 percent followed by Beaverton with 777 percent. Q. Which of Oregon's 10 largest cities has the highest percentage of blacks? A. Portland, with 7.7 percent. Salem is next with 1.5 percent.

Q. Which of Oregon's 10 largest counties has the highest percentage of whites? A. Deschutes County with 97.8 percent. Douglas and Linn counties are next with 96.9 percent.

Q. Which of Oregon's 10 largest counties has the highest percentage of Asians?
A. Benton County with 5.5 percent.
Washington County is next with 4.3 percent.

Q. Which of Oregon's 10 largest counties has the highest percentage of people of Hispanic origin? A. Marion County with 8 percent followed by Washington County with 4 6 percent.

I do indeed support your application to HUD for technical assistance. As a life-long resident of North Portland and a past officer of North Portland Citizens' Committee (now called Neighbors North I am all too familiar with the problems and concerns the families of Columbia Villa and Tamarack have long faced. Any program that will help you and your neighbors become more involved in the decision making process will get my full support.

When people feel they have no control of events, they become overwhelmed by a sense of helplessness and apathy...an "I don't care" attitude..."Nothing I do will change anything, so why bother." But, when people work together and receive the type of training you are requesting, they realize that they are very capable of making good decisions ad implementing them.

Not only will those people feel better about improving the quality of life in their community, but the attitude of younger residents will change, too. They will observe the results of unity and determination working from within "the system." People will be seen as managing and controlling their environment, not being run over by it. That is a very powerful image.

A strong, well organized resident council will also be viewed as an asset by the surrounding neighborhoods. They will see the council providing a reassuring, long-term stability and commitment to the area.

As the Metropolitan Service District Councilor for North Portland, I chair the North Portland Enhancement Committee (NPEC) which funds grants for use in North Portland. In the past four years, more than \$75,000 has been spent on projects

that directly and indirectly serve Columbia Villa and Tamarack. A large portion of those funds have gone to two organizations which deal almost exclusively with youth from Columbia Villa and Tamarack. North Portland Youth Service Center provides jobs and services for disadvantaged youth, and TLC/T'n'T are outstanding programs at Portsmouth Middle School providing activities and classes for at-risk youth. Other grants have funded literacy tutoring, litter patrol jobs for youth, and expansion of Delauney Mental Health Center.

It will continue to be in the best interests of North Portland to fund future enhancement grants that benefit Columbia Villa and Tamarack. And NPEC would welcome any economic development initiatives you'd wish to submit.

Good luck in your endeavors. I hope this letter will prove of value to your application.

On October 26, 1991, I attended a Congressional hearing conducted by Representative Ron Wyden at the Cascade Campus of Portland Community College. He was representing the House Subcommittee of Small Businesses and was listening to testimony on the Alberta Project headed up by Sam Brooks.

Memorandum

Project Alberta has been in the planning stage for several years and parts of the plan are now being implemented. Sam has recently located his office on Alberta and has extensively upgraded his location. He has long-range studies showing how a 30-block segment of Alberta could be developed into restaurants, shops, businesses and offices. The goal is to attract minority owners and small business people, and create an area of interest to Portlanders as well as tourists.

Sam asked me to speak, extemporaneously, after representatives of state, city and county governments had presented their support of the plan. My remarks are summarized as follows:

- * Metro has long recognized the importance of creating a strong and viable city-core on the east side.
- * Metro has shown its support of east side development with the recent construction of the Convention Center and the purchase of the Sears Building.
- * The Alberta Project could be another "gem" with which P/OVA could "sell" Portland as a convention city.
- * Metro supports all efforts by the community to attract visitors and provide new, creative enterprises promoting tourism.

I am very pleased to share information about the North Portland Enhancement Committee's Home Loan Grant program.

The money orignates from a service fee collected from users of the St. Johns Landfill (now closed). The enhancement committee decides upon the uses of this fund through yearly review of community grant proposals. However, this particular idea of funding home purchase was developed by the committee, itself, and led to a year of intensive talks with bankers, lawyers, realtors, and investment counselors.

I am sending you several pieces of literature as an overview of our project. Our brochure is available in banks, realtors' offices, neighborhood associations and other places of public access. We have also advertised in newspapers to let the public know about the fund.

The memorandum of understanding shows exactly what the banks agreed upon, although each bank has minor changes in the wording of its MOU. In order to simplify matters and broaden the availability of our funds, our payment structure ties in with banking procedures already in place. The numbers reflect Oregon guidelines in general, and Portland values in particular.

The certificate shown is filled out by the bank and then sent to Metro for payment. As of February 17, my office already had four completed certificates from home buyers and I anticpate a very successful use of this fund. Finally, I've also enclosed copies of two newspaper articles showing . support for this kind solution to a local problem.

I hope this information is helpful to you and the citizen groups with whom you are involved. Please let me know if there is anything further I can offer.
